PEACEFUL MEADOWS at Saratoga Springs

When natural burial is chosen, the full course of the Order of Christian Funerals should be celebrated, including the Vigil Service (wake), the Funeral Liturgy, and the Rite of Committal. The preservation of this order allows for the greater expression of our beliefs and values, especially, the sacredness of human life, the dignity of the individual person and the resurrection of Jesus Christ, the firstborn of the dead.

SPECIAL REGULATIONS

- 1. Only one full burial** is permitted per grave and two cremations are allowed on top of full burial permitting that the full burial takes place first, or three cremations in one grave. No mourners are allowed at gravesite during interment. A licensed funeral director and an able assistant must be present during the interment to assist at gravesite. Visitation is allowed only at memorial walkway, not at the gravesite.
- 2. Burial Containers:** Only burial shrouds or natural biodegradable caskets and urns can be used.
- 3. Burial vaults and cremation vaults:** Not permitted.
- 4. Embalming:** Not required (Please consult your Funeral Home).
- 5. Care and maintenance:** The area will be maintained to promote an undisturbed natural setting and will differ significantly from other sections of the cemetery.
- 6. Memorial:** Memorialization is limited to a natural granite block approximately 7" x10", provided only by the cemetery at no charge. Inscription is a separate charge. Pre-need memorials are not permitted. Absolutely nothing else can be placed on the graves. This will be strictly enforced.
- 7. Internment fee:** Standard interment fees apply.
- 8. Decorations:** Not permitted. ALL items will be removed.
- 9. Disinterment:** All interments in the Natural Burial Sections are considered permanent and disinterments from this section are not permitted. Purchaser acknowledges receipt of Special Regulations:

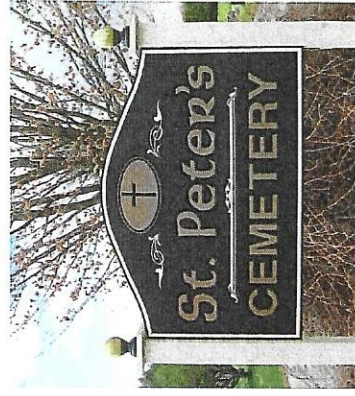

LOTS

1. Purchase price is \$800.00 per grave. This includes perpetual care. Graves cannot be resold.
2. Corner markers (set of four) are required for lots of two or more graves. Price is \$600.00 and are purchased through the Cemetery Office.
3. Graves will be sild in consecutive order and may be purchased in any number.
4. One full burial and 2 cremains are allowed in any grave.

INTERNMENTS

1. **Full Internment Fees:**
Spring/Summer- \$800.00 effective April 16th-November 14th
Fall/Winter-\$975.00 effective November 15th-April 15th
- Cremain Internment Fees:**
Spring/Summer: \$525.00 effective April 16th-November 14th
Fall/Winter: \$600.00 effective November 15th-April 15th

2. Deeds should be presented to Saint Peter's Cemetery Office. In the event deeds are lost, permission for burial can only be granted with a notarized proof authorizing the right to bury in said lot. Notarized statement of ownership are not necessary if you are the original owner and the deed is not lost or misplaced, or if you are the only living heir to the original owner.

3. Arrangements must be made with Saint Peter's Cemetery Office by the Funeral Director at least **48 hours** in advance of all internments.

4. No burials on a Saturday, Sunday or a holiday without special arrangements.

5. Saint Peter's Cemetery will not be held responsible for any disinterment or reburial.

Monuments

General Information:

1. Any person wishing to have a monument placed on a lot must contact the Saint Peter's Cemetery Office.
2. Owners will be billed for repairs which must be made by the Cemetery.
3. All monuments must be made of granite. Flush markers may be metal.
4. All monuments and markers must be on a foundation. All orders for foundations must be placed with the Saint Peter's Cemetery Office.

Monument Section

1. No more than one monument is permitted on each lot.
2. Monuments are permitted only on lots of two or more graves. The maximum base size permitted for monuments is 48" x 14" x 50" (48" base with planting urns and 60" without planting urns).
3. On a single grave a 24" x 12" flush marker is permitted.
4. **Effective September 1, 2006:**

The Cemetery reserves the right at all times to prescribe the kind, design, size, symbolism, crafting, quality and material of all memorials or inscriptions placed in the cemetery. Only Christian symbols are allowed. Full lifetime guarantee photo medallions are permitted. Any non-religious design depicted on a memorial must be subordinate in size and presentation to a religious design and approved by the cemetery. COMPLETE DRAWINGS of stone, portrait etchings and inscriptions must be submitted to the cemetery office for approval. Any item appearing on the stone other than what was submitted and approved will be in violation and will have to be removed at the monument dealer's expense. Second offense of items appearing on the stone other than approved drawing will result in dealer being banned from the cemetery.

Shrine Section

Flush markers only are permitted. (No urn pads are permitted).

2. On lots of two or more graves the maximum marker size is 48" x 14" to be placed at the head of the lot. On these lots smaller markers (24" x 12") are permitted on individual graves, to be placed at the foot of the lot, only after burial.
3. On a single grave a 24" x 12" flush marker is permitted.

CARE OF LOTS

PERMITTED

(Effective October 1998)

A. Live (Fresh) Flowers:

Placed in an urn (concrete) at the side if the memorial stone. NO in-ground planting allowed. NO clay, plastic or wood pots allowed.

B. Live Shrubbery:

Not to exceed 18 inches. To be placed in an urn (concrete) only, at the side of the memorial stone.

C. Live (Fresh) Wreaths:

Attached to the memorial stone by a proper holder (saddle), or set in an easel. All wreaths must be removed after the New Year.

D. Flags-Veterans and Societies:

Allowed Memorial Day through Labor Day.

E. Shrine Section-Urns:

Are allowed on flush markers (memorial stones) from Memorial Day through Labor Day, at which time the urns must be removed by the lot owner.

F. NO ANIMALS are allowed in Saint Peter's Cemetery. No trespassing and No dumping of materials.

LOT OWNERS ARE RESPONSIBLE FOR THE REMOVAL OF ANY OF THE ABOVE ITEMS AT THE END OF THE SEASON. AFTER THAT TIME, THE SUPERINTENDENT OF THE CEMETERY HAS THE RIGHT TO REMOVE SAID ITEMS.

THE CEMETERY WILL NOT BE RESPONSIBLE FOR THE THEFT OF, OR DAMAGE TO, URNS, FLOWERS, OR WREATHS PLACED ON THE LOTS.
